

Event Attendance Terms, Liability Acknowledgment & Media Release

By submitting this RSVP and/or attending the Wellball Open Tour Founders Edition at Center Court Sports, I acknowledge and agree to the following terms on behalf of myself and, if applicable, any guests listed in my RSVP group.

1. Event Attendance

I understand that admission to the event is subject to capacity limits, event staff approval, venue policies, and all applicable rules and regulations. I voluntarily assume all risks associated with attending the event, whether known or unknown, foreseeable or unforeseeable, except to the extent prohibited by applicable law.

3. Liability Release

To the fullest extent permitted by law, I release, waive, and discharge Wellball, its owners, officers, directors, employees, contractors, representatives, sponsors, partners, affiliates, event operators, volunteers, Center Court Sports, and any related parties from any and all claims, liabilities, demands, damages, costs, or causes of action arising out of or related to my attendance at the event.

This release includes, but is not limited to, claims for personal injury, property loss, property damage, illness, or any other harm that may occur in connection with attending the event, except where such release is not permitted by applicable law.

4. Medical Acknowledgment

I understand that Wellball and event staff do not guarantee the availability of on-site medical care. In the event of an emergency, I authorize event staff to seek emergency assistance if deemed necessary. I understand that I remain responsible for any medical costs or expenses incurred as a result of my attendance.

5. Media & Appearance Release
